Since this course is closely related to the real world economic events, students are encouraged to pay more attention to the financial news and related information on the web or in the newspapers and business-type magazines. The exams might ask students to analyze the related news reports.

Grading Policy

Exams: 70%. There will be one mid-term exam and a comprehensive final examination. The mid-term exam will account for 30% and the final exam will account for 40% of the total grade.

General performance: 30%. It includes: quizzes, homework, presentations, classroom games...etc. The purpose of these activities is to help students assimilate the materials taught in the class and prepare for the exams.
