#### 課程描述 Course Description

此課程主要利用經濟理論模型,探討各種常見的國際貿易問題。涵蓋的議題有:

- 1. 出口政策:台灣經濟出口導向,最適的出口政策應為何?
- 2. 進口政策:進口一定課稅嗎?
- 3. 產業內貿易:比較利益原則不存在了嗎?
- 4. 差別關稅:產品來自不同的國家是否應該課不同的稅?
- 5. 關稅與配額:進口產品應實施關稅政策還是配額政策?
- 6. 品質:進口產品的品質如何受到貿易政策的影響?
- 7. 傾銷政策:採取反傾銷政策真的對國內廠商好嗎?
- 8. 國際間之環境政策:環境議題在國際貿易政策中的重要性如何?
- 9. 貿易利得:開放自由貿易一定會史社會福利增加嗎?
- 10. 經濟整合ECFA(海峽兩岸經濟合作架構協議)效應:福利效果分析。

以上這些議題當然不是策略性貿易議題的全部,我們希望透過上述議題的討論,可使學生進一步了解政府政策與廠商行為之間的策略性關係。除此之外,可訓練學生利用嚴謹的經濟理論方法分析我們面臨的經濟議題。

### 課程目標 Course Objectives

因交通的發達與資訊的便利性,國與國之間的界限愈來愈模糊。跨國廠商的數目也不斷的增加,晚近興起代工熱潮,廠商如何在代工與整廠往外移之間作抉擇等等,這些都是最近在產業界,國際經濟中熱門的話題。本課程主要介紹跨國企業的形成以及跨國企業對經濟的影響,國際情勢訊息萬變,希望學生在學習的過程中,可以嗅到一些國際產業發展的趨勢,不管是未來在就業或繼續深造上有些幫助
