課程描述 Course Description					
This is a graduate course in international trade theory and policy analysis for M.A. and Ph.D. students in economics. A modest background in mathematics and microeconomic theory will be assumed. The objective is to provide a self-contained introduction to modern work on international trade theory and policy. Specific topics include: strategic trade policy, international trade institutions and rules, the policy economy of trade policy, gravity model, direct foreign investment and multinational firms, and outsourcing.					
課程目標 Course Objectives					
This course will provide students with the ability to conduct and evaluate economic analyses of policy issues relating to international trade. The course begins with a discussion of the reasons why countries trade. It proceeds to a discussion of the arguments for and against protection and managed trade. We study the effects of different trade policy instruments. Then we discuss the issues that arise in the design of policy for declining, import-competing industries, and for dynamic, export industries.
