### 課程描述 Course Description

The purpose of this course is to study the firm's investment, financing, and dividend decisions. The primary goal is to teach students how to use financial information and theory in financial management and financial decision making. The main readings for the course are Fundamentals of Corporate Finance, Second Edition, Berk, J., DeMarzo, P., and Harfold, J.. Besides, the class will combine lectures with detailed paper discussions and presentation. You are also expected to attend every class, unless you have an excused absence due to illness or an emergency. If you must miss a class session, it is your responsibility to notify me by email, if possible in advance of class indicating the reason for the absence. Failure to do so may result in an unbounded random penalty to your class participation grade. There are a total of 6 homework assignments. Your homework grade is based on the 5 best assignments, so you may choose to drop one of them. Homework assignments are due at the beginning of class. The course Midterm and ends with a 3-hour, closed-book in class-exam. Therefore, your grade for this class will be determined by class participation and discussion (10%), homework assignments (30%), a midterm-examination (30%), and a final Examination (30%).
