The primary goal is to teach students how to use financial information and theory in financial management and financial decision making. The main readings for the course are Fundamentals of Corporate Finance, Second Edition, Berk, J., DeMarzo, P., and Harfold, J.. Besides, the class will combine lectures with detailed paper discussions and presentation. Failure to do so may result in an unbounded random penalty to your class participation grade. There are a total of 6 homework assignments. Therefore, your grade for this class will be determined by class participation and discussion (10%), homework assignments (30%), a midterm-examination (30%), and a final Examination (30%)
