課程描述 Course Description

This is an intensive course for risk analysis; primarily focus on financial institutions which banking industry is part of it. Financial risk management is becoming crucially important for any financial institutions nowadays. (I would rather say it is not only important for financial institutions, but also for any corporations.) In last decade, numerous examples prove the importance of financial risk management. One of the well-known example is the collapse of the England oldest bank which served the royal families for hundreds years. After joining WTO, more financial products will be introduced into Taiwan market. Therefore, demand for financial risk management will rise. Our intention is to provide a solid foundation for students in financial risk management for financial institutions.
