Students are expected to attend every class, unless having an excused absence due to illness or an emergency. If one must miss a class session, it is his/her responsibility to notify me by email, if possible in advance of class indicating the reason for the absence. Failure to do so may result in a penalty to your class participation grade. Homework assignments are due at the beginning of class. The course Midterm and ends with a 3-hour, closed-book in class-exam. Therefore, students' grade for this class will be determined by class participation and discussion (10%), homework assignments (30%), a midterm-examination (30%), and a final Examination (30%).</p>
