課程描述 Course Description

國際貿易議題的探討。為何要對進口產品課關稅?廠商為何要外包?出口好或直接投資好?經濟整合對社會福利的影響?貿易自由化對國內工資的影響?貿易自由化對國內汙染量的影響。

本課程希望藉由所學的經濟知識,再配合現實社會經濟現象的觀察,做科學性的分析,提供學生一個思考方法,進一步判斷輿論是非。

在課堂上討論研究方法,思考問題的邏輯性。

希望培養對做研究有興趣的同學,可進一步撰寫論文。

課程目標 Course Objectives

因交通的發達與資訊的便利性,國與國之間的界限愈來愈模糊。跨國廠商的數目也不斷的增加,晚近興起代工熱潮,廠商如何在代工與整廠往外移之間作抉擇等等,這些都是最近在產業界,國際經濟中熱門的話題。本課程主要介紹產業間的競爭行為如何影響國際貿易的發生,以及貿易進行的模式:進出口、跨國投資、技術授權等方式,以產業競爭的角度來探討國際貿易發生後,對廠商競爭的影響,國內人民福祉的變化,以及國家社會福利的變化,進而擴展至全球福利的變化。重點在於以產業的競爭方式來討論市場結構,以及當市場結構為不完全競爭時政府的最適貿易政策。國際情勢訊息萬變,希望學生在學習的過程中,可以感受到產業發展的趨勢,不管是未來在就業或繼續深造上有些幫助。
