課程描述 Course Description				
<p>The main purpose of this course is to discuss international trade issues by integrating industrial organization theory. Why do we impose tariffs on imported products? Why do manufacturers outsource? Export or direct investment for a multinational firm, the impact of economic integration on social welfare, the effect of trade liberalization on domestic wages, and the impact of trade liberalization on domestic pollution, and so on.</p> <p>This course hopes to use the economic knowledge we have learned, coupled with the observation of economic phenomena, to do scientific analysis, and to have a better judgment on public issues.</p> <p>We are going to discuss the research methods in class, think about the logic of the problem, and set a model to find out the solution.</p> <p>I hope to train students who are interested in doing research. Students can apply this skill for futher research.</p>
