#### 課程描述 Course Description

This is an introductory course in corporate finance. The course has three main objectives: (1) Develop an understanding of the tools that are used to value investment projects and companies (valuation). (2) Understand the basic issues involved in how firms should raise funds for their real investments (financing). (3) Evaluate how investment and financing decisions are related. Emphasis will be placed on appreciating the limitations and challenges that are faced when applying the theoretical framework of corporate finance to real world problems.

The prerequisite for this class is a passing grade in Accounting. Therefore, it is expected that students will be comfortable with the following topics: time value of money, discounted cash flow analysis, risk-return trade-off, diversification, valuation of bonds and stocks, Capital Asset Pricing Model (CAPM).

### 課程目標 Course Objectives

Financial knowledge is becoming increasing important in recent decade, especially after the sub-prime mortgage crisis. This course is an introduction to corporate finance. It covers the theories and practices of decision making within firm. Other interesting topics will be discussed in class.
