#### 課程描述 Course Description

The main purpose of this course is to discuss international trade issues by integrating industrial organization theory. Why do we impose tariffs on imported products? Why do manufacturers outsource? Export or direct investment for a multinational firm, the impact of economic integration on social welfare, the effect of trade liberalization on domestic wages, and the impact of trade liberalization on domestic pollution, and so on.

This course hopes to use the economic knowledge we have learned, coupled with the observation of economic phenomena, to do scientific analysis, and to have a better judgment on public issues.

We are going to discuss the research methods in class, think about the logic of the problem, and set a model to find out the solution.

I hope to train students who are interested in doing research. Students can apply this skill for futher research.

#### 課程目標 Course Objectives

因交通的發達與資訊的便利性,國與國之間的界限愈來愈模糊。跨國廠商的數目也不斷的增加,晚近興起代工熱潮,廠商如何在代工與整廠往外移之間作抉擇等等,這些都是最近在產業界,國際經濟中熱門的話題。本課程主要介紹產業間的競爭行為如何影響國際貿易的發生,以及貿易進行的模式:進出口、跨國投資、技術授權等方式,以產業競爭的角度來探討國際貿易發生後,對廠商競爭的影響,國內人民福祉的變化,以及國家社會福利的變化,進而擴展至全球福利的變化。重點在於以產業的競爭方式來討論市場結構,以及當市場結構為不完全競爭時政府的最適貿易政策。國際情勢訊息萬變,希望學生在學習的過程中,可以感受到產業發展的趨勢,不管是未來在就業或繼續深造上有些幫助。
