課程描述 Course Description					
The purpose of this course is to study firms' investment, financing, and dividend decisions. The primary goal is to teach students how to use financial information and theory in financial management and financial decision making. The main readings for the course are Fundamentals of Corporate Finance, Fifth Edition, Berk, J., DeMarzo, P., and Harfold, J. Students are expected to attend every class, unless having an excused absence due to illness or an emergency. If one must miss a class session, it is his/her responsibility to notify the teachers by email, if possible in advance of class indicating the reason for the absence. Failure to do so may result in a penalty to your class participation grade. Homework assignments are due at the beginning of class. The course Midterm and ends with a 3-hour, closed-book in class-exam. Therefore, students' grade for this class will be determined by class participation and discussion (10%), homework assignments (30%), a midterm-examination (30%), and a final Examination (30%).
