課程描述 Course Description					
The purpose of this course is to study firms’ investment, financing, and dividend decisions. The primary goal is to teach students how to apply financial information and theory to financial management and decision-making. The main readings for the course are Fundamentals of Corporate Finance, Fifth Edition, by Berk, J., DeMarzo, P., and Harford, J. Students are expected to attend every class unless they have an excused absence due to illness or an emergency. If one must miss a class session, it is their responsibility to notify the teachers by email, if possible, in advance of class, and to indicate the reason for the absence. Failure to do so may result in a penalty to your class participation grade. Homework assignments are due at the beginning of class. The course midterm ends with a 3-hour, closed-book in-class exam. Therefore, students’ grade for this class will be determined by class participation and discussion (10%), homework assignments (30%), a midterm examination (30%), and a final Examination (30%).
